Regular Members of BAC-A shall serve for a period of one (1) year commencing on the date of the approval of this Circular and shall end a year thereafter.


To expedite the procurement process, all the Regular Members of BAC-A shall give outmost priority to BAC assignments over all other duties and responsibilities, until all requirements for the said assignment at hand are completed.

The list of regular members of the Technical Working Group (TWG) shall be taken from a pool of technical, financial and/or legal experts and shall be named in subsequent issuances, supplementary to this Circular.

Outgoing members of the BAC shall continue to discharge their functions until the completion of all on-going procurements for which they have been constituted. The new incoming procurements shall be handled by the duly reconstituted BAC-A in accordance with this Circular.

This Memorandum Circular shall take effect immediately and shall supersede all existing memoranda and all orders inconsistent herewith and shall remain in force unless otherwise revoked.
