

MEMORANDUM CIRCULAR

TO

: ALL NEC-AID RETURNED PARTICIPANTS CENTRAL & FIELD OFFICES National Irrigation Administration

SUBJECT : Applications for Benefits Under the Participant Follow-Up and Evaluation Program

You are hereby informed that the NEC, US-AID and the Civil Service Commission have jointly launched a Participant Follow-Up and Evaluation Project for returned participants. The objective of this Project is to assist returned participants in utilizing their training more effectively by providing them with the additional technical information they need to fulfill their training objectives.

Per Memorandum Circular no, 3 of the Civil Service Commission dated January 18, 1968, the following guidelines shall be observed:

1. Who may avail of the benefits:

Only those individuals who have received training under a joint Philippine-American program of the present U.S. Agency for International Development (US-AID), or the former Economic Cooperation Administration (ECA), the Foreign Operations Administration (FOA), the Mutual Security Agency (MSA), and the International Cooperation Administration (ICA) are eligible.

- 2. Implementing Criteria and Procedures:
 - a. Membership in American professional societies or subscription shall be one (1) year at a time, as far as practicable.
 - b. Criteria for Selection :
 - (a) Relative importance of the field in which the returned participant is currently engaged to national economic development.
 - (b) Availability or non-availability of other sources of up-to-date information in the field.
 - (c) Priorities shall be given to :

(1) Participants whose present positions

involve them in existing joint projects or those whose present duties have a direct bearing on their area of training,

- (2) Participants whose leadership rolescurrent or potential, teaching skills, and other activities give them multiplier impact.
- (d) Returned participants who still enjoy memberships which were originally subscribed during or immediately after their training in the U.S. shall be given last priority.

All interested and qualified returned participants are requested to fill up in quintuplicate the attached prescribed forms (A & B) and to submit the same to this Office, (ATTN: 0 & M, Mgt. Staff) not later than February 10, 1968, so as to allow this Office enough time to process such applications. Deadline set by the CSC for the submission of Ågency nominees to the project is February 15, 1968.
