MEMORANDUM CIRCULAR NO. 195

SUSPENDING PAYMENT OF SALARY OF OFFICIALS AND EMPLOYEES
WHO DID NOT FILE THEIR INCOME TAX RETURNS FOR 1967,

Under Memorandum Circular No. 192 of this Office dated June 17, 1968, all departments, bureaus, offices and entities in the executive branch of the government, as well as independent offices, are required to prepare and submit to this Office lists of officials and employees under them who have gross income of ₱1,800 or more during the calendar year 1967 but failed to file their their corresponding income tax returns.

In connection therewith, it is hereby directed that the payment of salary of officials and employees who have been so listed as not have filed their income tax returns be suspended beginning with the salary due on July 15, 1968. All heads of departments, and chiefs of bureaus and offices, including independent offices, are hereby enjoined to require their cashiers, special disbursing officers, paymasters, or similar officials, to comply with this directive.

It should be stated that, notwithstanding repeated follow-ups, only a few offices have complied with the requirement to submit lists of non-filers. Notice is hereby given that the salaries of heads of departments and chiefs of bureaus and offices, as well as of independent offices, will be ordered suspended if within fifteen (15) days from the date hereof the lists required of them under Memorandum Circular No. 192 will not have been received in this Office.

Strict compliance hereof is enjoined.

The above quoted Memorandum Circular is a supplement to MC # 55, s. 1968 of this Office dated June 25, 1968 circularized to all Central Office and field officials requiring the submission of lists of officials and employees of this Agency who failed to file their Income Tax Returns. It is informed, in this connection, that only the (1) Central Office, (2) Office of the Regional Irrigation Engineer, Region 3, (3) Office of the Provincial Irrigation Engineer, Daet, Camarines Norte and the (4) Office of the Project Engineer, Aklan River Irrigation Project, Banga, Aklan have so far responded to the aforesaid MC # 30, s. 1968 above mentioned.

In view thereof, other chiefs of offices not hereinabove mentioned are hereby warned that their salaries will be ordered suspended if within fifteen (15) days from the date hereof the lists required of them under Memorandum Circular No. 192 shall not have been received by the Records Division, Office of the President of the Philippines and copy furnished this Office.

Prompt compliance hereon is enjoined.
