## SUBJECT : Revised Rations of WFP Commodities

In compliance to the UNDP/Philippines, letter of March 18, 1969 please be informed that effective April 16, 1969, the new WFP ration per worker per quincena (11 working days) shall be as tabulated below:

The quantities of WFP items shown above are the maximum a worker may buy or receive of each kind. The above tabulation supercedes all ration systems under previous memorandum circulars on WFP foods.

The items of vegetable oil, canned cheese and canned butter are not yet available for the present. For this reason, the rations and costs for the particular items of canned cheese and butter are just approximate and may be subject to change, depending on the actual sizes of containers they will come in.

On the item of canned fish, both cans of 200 grams or 155 grams are priced the same, at P.25 each.

Please be informed that in accordance with our request, the UNDP is also allowing us to give the above tabulated quantities of WFP items as incentive for work for the repair or improvement works in NIA irrigation systems.

In the absence of actual cash for wages, each worker may receive, for one "quincena" work (11 working days) not more than the above tabulated quantities of WFP foods, as his incentive for work.

All statements or information in previous memorandum circulars on WFP commodities, not contradictory to the herein provisions are still enforced.
