#### SUBJECT CSC Announcement re: FIRST GRADE Examinations

You are hereby informed that the Civil Service Commission recently announced the holding of entrance and qualifying examinations on the FIRST ORADE level to be held on May 30, 1971 in the following cities: Manila, Cebu, Davao, Iloilo, Naga and Baguio,

Hereunder are particulars of the examination:

### FILING OF APPLICATIONS

AND TOWNED A ST Applications must be filed with the Civil Service Commission, P. Paredes St., Manila, D-403, or the Local Examining Committee in the place where the applicant intends to take the examination, not later than March 19, 1971, or if mailed, must be postmarked not later than March 19, 1971.

# MINIMUM REQUIREMENTS

Education and Experience:

A. ENTRANCE

Applicants must have graduated with a bachelor's degree from a college or university of recognized standing.

B. QUALIFYING

Applicants must:

- Have graduated with a bachelor's degree from a college 1, or university of recognized standing;
- 2. Be actually in the government service, and hold or have held, a position in the competitive service;
- 3. Have qualified in the Second Grade examination or its equivalent; and,
- 4. Have at least 3 years of experience in the government service,

### Substitution allowed:

Applicants who do not possess a bachelor's degree but have been in the government service at least five years may substitute one year's experience in the competitive or noncompetitive service for one year of deficiency in the college education required, but only 2 years of educational deficiency may be substituted by experience.

Education and experience required should be duly certified.

### Age Limits:

Applicants must be not less than 18 or more than 35 years of age on the date of the examination. The age limits do not, however, apply to those who are already in the government service on the day of the examination.
