MEMORANDUM CIRCULAR

TO : THE CHIEF, PROCUREMENT DIVISION, CENTRAL OFFICE; HEADS OF THE UPRP, UNDP-GWDP, MAGAT RIVER PROJECT FEASIBILITY STUDY AND COTABATO RIVER PROJECT; REGIONAL PROVINCIAL AND PROJECT IRRIGATION ENGINEERS; IRRIGATION SUPERINTENDENTS AND OFFICERS-IN-CHARGE OF IRRIGATION SYSTEMS/OFFICES; AND ALL OTHERS CONCERNED.

SUBJECT : ENJOINING ALL GOVERNMENT OFFICES & AGENCIES TO PURCHASE THEIR SUPPLIES & EQUIPMENT FROM THE COTTAGE INDUSTRIES DEVELOPMENT ENTERPRISE (CIDE) AND THE REGISTERED PRODUCERS OF THE NATIONAL COTTAGE INDUSTRIES DEVELOPMENT AUTHORITY, THRU THE NACIDA.

Quoted hereunder in full is Memorandum Circular No. 528 from the Office of the President of the Philippines, dated January 4, 1972:

"MEMORANDUM CIRCULAR NO. 528

"ENJOINING ALL GOVERNMENT OFFICES & AGENCIES TO PURCHASE THEIR SUPPLIES & EQUIPMENT FROM THE COTTAGE INDUSTRIES DEVELOPMENT ENTERPRISE (CIDE) AND THE REGISTERED PRODUCERS OF THE NATIONAL COTTAGE INDUSTRIES DEVELOPMENT AUTHORITY, THRU THE NACIDA.

"In order to assist the CIDE and the NACIDA in their participation in the Program for Rural Employment and thereby promote the development of cottage industries, all departments, bureaus, or offices including local subdivisions and government-owned or controlled corporations are hereby enjoined to purchase from the CIDE's production units and the registered producers of the National Cottage Industries Development Authority, all their supplies and equipment, thru the CIDE and/or the NACIDA.

"To effect implementation of this Circular, all the above-mentioned government offices and agencies are hereby required

to submit to the CIDE and the NACIDA through the Director of the Bureau of Supply Coordination, a list of their immediate and future supply and equipment requirements within ten (10) days after receipt of this Circular.

"It is understood that should the CIDE's and NACIDA's authorized representatives certify that the supplies and equipment cannot be produced by the CIDE's production units and/or NACIDA registered producers, the usual government procurement operations shall be observed.


"This Memorandum Circular amends and modifies Memorandum Circular Nos. 356 and 484.



## OFFICE MEMORANDUM NO. 429

TO : All Department Managers and Auditors of Bureaus and Offices of the National Government and Others concerned.

SUBJECT : Memorandum Circular No. 484 of the Office of the President of the Philippines, enjoining all Government Offices and Agencies to purchase their supplies and equipment from the Cottage Industries Development Enterprise (CIDE) and the National Cottage Industry Development Authority (NACIDA) Registered Producers.

For the information and guidance of all concerned there is quoted hereunder in full Memorandum Circular No. 484 of the President of the Philippines, dated July 20, 1971:

## "MEMORANDUM CIRCULAR NO. 484

"ENJOINING ALL GOVERNMENT OFFICES & AGENCIES TO PURCHASE THEIR SUPPLIES & EQUIPMENT FROM THE COTTAGE INDUSTRIES DEVELOPMENT ENTERPRISE (CIDE) & THE NATIONAL COTTAGE INDUSTRY DEVELOPMENT AUTHORITY (NACIDA) REGISTERED PRODUCERS.

"This Memorandum Circular supersedes Memorandum Circular No. 356.
