Projects and Irrigation Systems and an Increase
of Fifty Pesos (P50.00) in the Representation
Allowance of Regional Irrigation Engineers

Pursuant to Board Res. No. 1723-72, you are hereby informed,
that the key field officials hereunder listed are granted new or
increased representation allowances as follows:

A. Regional Irrigation Engineer	P200.00
B. Chief, Operations Division (Reg'l Office)	100.00
C. Chief, Engineering Division (Reg'l Office)	100.00
D. Field Engineers designated by the Administrator as Officer-in-Charge of <u>National Irrigation</u> <u>Projects</u> and with duly approved appointments as:	
a) Associate Civil Engineer	50.00
b) Civil Engineer	75.00
c) Senior Civil Engineer	100.00
E. Field Engineers designated by the Administrator as Acting Irrigation Superintendent or Officer- In-Charge of <u>irrigation systems</u> who have duly (approved appointments as):	
a) Associate Civil Engineer	50.00
b) Civil Engineer	50.00
c) Senior Civil Engineer	75.00
d) Supvg. Civil Engineer I	100.00


In this connection, please take note of the following:

- (a) The increase in representation allowances for Regional Irrigation Engineers by fifty pesos (P50.00) per month is an addition to the existing one hundred fifty pesos (P150.00) as authorized under Board Res. No. 1631-71. The increase shall be effective May 1, 1972.
- (b) Other officials receiving the representation allowance for the first time, the date of effectivity shall be March 1, 1972.

- (c) Those other officials not falling under items (a) and (b) mentioned in this paragraph and who were previously entitled to representation allowance shall receive the difference effective March 1, 1972.

Further, this memorandum circular hereby amends and/or modifies the clarification as contained in MC #37, s. 1972 issued pursuant to Board Res. No. 1631-71 on representation allowances, insofar as field engineers acting as Irrigation Superintendents or Officers-In-Charge of irrigation systems are concerned.

Please be guided accordingly.
