MEMORANDUM CIRCULAR

TO

THE ASSISTANT ADMINISTRATOR; CHIEFS OF DEPARTMENTS AND STAFFS; REGIONAL IRRIGATION ENGINEERS; PROVINCIAL IRRIGATION ENGINEERS; IRRIGATION SUPERINTENDENTS WITHIN CALAMITY AREAS AND ALL OTHERS CONCERNED This Agency

SUBJECT

Implementation of Projects under the <u>Oalamity Fund Act</u>, <u>Designating Special</u> <u>Project Coordinators and Project Engi-</u> <u>neers to undertake the same</u>

This is to inform you that under the provisions of the Calamity Fund Act, funds have been allocated and released to NIA to undertake immediate rehabilitation of irrigation facilities in existing national irrigation systems and including communal systems and/or projects damaged by floods and typhoons in the months of June and July, 1972, in the provinces of Bulacan, Bataan, Zambales, Pampanga, Tarlac, pangasinan, Laguna and Nueva Ecija.

Pursuant to the provisions of the Calamity Fund Act, the following guidelines are to be observed in the disbursement of funds:

Under Sec. 1 (a)

(1) The amount released shall be spent and actually disbursed not later than March 31, 1973 except for on-going projects started before March 31, 1973 but not beyond June 30, 1973

VaderaSec.1 (g)

(2) The amount released shall be spent and actually disbursed not later than September 30, 1972.

In this connection, it shall be understood that work under Pacquia Contract is not considered personal services nor operational expenses.

In view of the urgency of undertaking the prosecup tion of the rehabilitation projects within the period specified in the Calamity Law, there is hereby designated Special Project Coordinator for the following provinces and Project Engineers for Irrigation Systems. A Special Project Coordinators

The Irrigation Superintendent or Officerin-Charge of the Irrigation System is automatically designated as Special Project Engineer of the project in his system.

There is hereunder stated the duties and responsibilities of the above named Coordinators and Project Engineers in so far as these Special Projects are concerned as follows:

DUTIES OF PROJECT COORDINATOR

- 1. Collaborate with the overall coordinator in the preparation of General Schedule of assigned projects; recommend necessary changes in the same, if necessary as work progresses.
- 2. Prepare Programs of work; review construction schedules prepared by Project Engineer.
- 3. Allocate, assign and/or transfer equipment in the different system or group pool within areas of jurisdiction; where equipment in the area is not sufficient, request the Regional Irrigation Engineer concerned for deficiency.
- 4. Procure and allocate needed supplies and materials such as steel bars, cement, sheet piles lumber, aggregates boulder; approve requisitions for issuance, from stock or for local purchase or for Central Office procurement using the procurement outfit of the systems/projects.
- 5. Inspect and evaluate construction activities, progress and accomplishments and expenditures in accordance with approved Programs of work and Schedules.
- 6. Discuss jointly with Project Engineer areas of delay and work out remedial measures to speed up the work whenever necessary; collect and review the required reports, in formats prescribed, for submittal to the overall Coordinator.
 - 7. Recruit supervisory and survey personnel such as Junior Civil Engineers, Civil Engineering Aides, Foremen, Survey men, etc. needed for the projects.

DUTIES OF PROJECT ENGINEER

- 1. Prepare details of work to be done and schedules to be followed based on General Schedule prepared by the overall Coordinator in collaboration with the Project Coordinator. Details shall include, among others, the following:
 - a) Detailed schedule of work which shall be supported by detailed listing of work by canal, principal structures such as diversion works and structures needing major repairs, drainage channels, etc. furnishing exact quantities of work (cu.m. of earthwork, borrow, borrow haul, reinforced concrete volume, rip-rap, grouted rip-rap, etc.). A layout showing the work to be done shall be attached.
 - b. Construction schedule (Bar charts).
 - c. Manner of prosecuting the work (By pacquiao contract or direct administration).
 - d. Manpower requirement.
- 2. Prepare listing of equipment and materials needed. (Indicate available equipment, the total requirement and the additional needs. For materials, indicate the quantity of cement, steel bars, steel sheet piles, lumber, boulders, aggregate; monthly in a Bar chart with date.)
- 3. Undertake implementation of the project in accordance with program of work and construction schedules.
- 4. Hire laborers- carpenters, masons, drivers, mechanics, etc. needed for the project.
- 5. Approve vouchers and payrolls and paquiao contracts
- 6. Prepare requisition for supplies and materials not covered in the Schedule
- 7. Prepare reports in accordance with formats to be prescribed.

It is to be understood, that the designation of Special Project Coordinatons and Project Engineers are in addition to their regular duties and responsibilities and without additional compensation, and that their present station shall remain as their headquarters.

In view of the urgency of undertaking these Special Projects, Regional Irrigation Engineers are hereby directed to extend full cooperation and support to the Special Project Coordinators and Project Engineers whenever and wherever necessary and requested.

<u>Attached</u> herewith is a copy of the Calamity Fund Act for ready reference and permanitaking into consideration the limitations indicated therein.

The Memorandum Circular takes effect upon approval unless otherwise revoked and/or modified accordingly. All concerned herein are hereby directed to comply immediately.

Please be guided accordingly.
