

SUBJECT : Registration of pumps and purchase of fuels

In order to identify and aid the farmers in getting an adequate supply of fuel for their irrigation pumps, the following directives should be implemented immediately;

1. Advise farmers owning irrigation pumps acquired from the former Irrigation Service Unit (ISU) of NIA to show copies of their sales contract (for the pumps) to the authorized dealers of gasoline and oil (within their localities) whenever they want to buy fuels for said pumps.
2. Advise all farmers owning irrigation pumps acquired from other sources to register their pumps with the nearest NIA Office.
Verify if these pumps are being used for irrigation purposes and if in the affirmative, the owners should be issued a registration I.D. card, sample copy of which is attached hereto. This I.D. card should be presented also by the holders to the authorized dealers of gasoline and oil whenever buying fuels.
3. Advise the pump owners to limit their purchases of fuels to not more than a month's supply.
4. Report to the Administrator, towns or areas within your jurisdiction which have become dry due to lack of fuels but which are supposed to be serviced by oil companies under the Bureau of Supply DOPS purchase system. In case of complaints of lack of oil in your locality, verify from the existing dealers in the locality concerned the last delivery made to them by the oil companies.
5. Arrange with the local service stations to record their sales of fuels to pump owners showing dates, and quantities. Make a monthly summary report to the central office of the quantities of fuels purchased by the farmers for their pump irrigation.
