> This is to supplement Department Order No. 10-74 of national internal revenue collections to the Arpay of the Treasury through direct deposits with the Development Bank of the Philippines and its branches.

In view of the considerable benefits derived by the national government from the expeditious inflow of collections to the National Treasury and to help in strengthening the cash operations of DEP as a government depository, it is hereby directed that remittance of national collections thru the DBP be expanded to include not only internal revenue collections but all national collections similarly authorized for FNB and PVB prescribed under Department of Finance Orders Nos. 20-73 and 23-73, dated June 14, 1973 and August 22, 1973, respectively. Accordingly, national collecting officers are authorized to remit their collections in rough direct dependents to the DBP Head Office and/ or to any of its branches and agencies.

State provisions of Department Order No. 10-74 not allorate provision of this Order shall remain in forme and street.
