TO; ALL HEADS OF DEPARTMENTS, CHIEFS OF BUREAUS AND OFFICES, MANAGING HEADS OF GOVERNMENT-OWNED OR CONTROLLED CORPO-RATIONS AND OTHERS CONCERNED

There has been, lately, rumors that the granting of lump sum retirement gratuity benefits under R.A. 660 as amended by R.A. 1616 shall be stopped by June, 1976. These rumors evidently are widespread causing undue apprehensions among government employees.

In this connection, we wish to deny these rumors strongly. There is neither a study conducted nor a proposal being made to stop the granting of lump sum benefits to either retirees who retire under R.A. 660 or those who retire under R.A. 1616- now or in the future.

The lump sum gratuity benefit is granted by explicit provisions of the law. This benefit, therefore, can only be removed, reduced or amended through a decree signed and promulgated by the President of the Philippines. The System can not unilaterally amend the provisions of the law - and there are no plans whatsoever to propose the amendments of the law to deprive the members of benefits they now presently enjoy. On the contrary, the System has been always in search for ways and means to improve the present retirement benefits as evidenced by the recent implementation of an index-linked annuity shheme. Rest assured, therefore, that the rumors being circulated are plain rumors that are without basis.

We will be very thankful, therefore, if you can clarify this matter with the officials and employees in your Office in order to allay their fear of losing their retirement benefits.
