- SUBJECT: IMPROVED AND UPDATED GENERAL FORM NO. 57 (A), REQUEST FOR BONDING AND/OR CANCELLATION OF BONDS OF ACCOUNT-ABLE OFFICIALS AND EMPLOYEES OF THE REPUBLIC OF THE PHILIPPINES AND GENERAL FORM NO. 58 (A), APPLICATION FOR BOND OF OFFICIALS AND EMPLOYEES OF THE REPUBLIC OF THE PHILIPPINES.

The above General Forms have been revised to improve and update them and make them more responsive to the present needs. These are so designed to facilitate transcription of data by computers and to further safeguard or protect the interests of the government as bondsman of its employees. On these premises, the Acting Chairman of the Commission on Audit interposed no objection to the revision while the Honorable, the Secretary of Finance, in his 3rd Indorsement dated March 24, 1976, approved the revised forms pursuant to Section 315 of the Revised Administrative Code.
