SUBJECT : INCLUSION OF ORGANIC FERTILIZER IN THE EXPANDED CORN PROGRAM INTENSIFIED RICE PRODUCTION PROGRAM AND NATIONAL SOYBEAN PRODUCTION PROGRAM

PURSUANT TO MEMO DATED JANUARY 4, 1985 DIRECTING ALL REGIONAL DIRECTORS AND PROVINCIAL AGRICULTURAL OFFICERS OF THE MINISTRY OF AGRICULTURE AND FOOD FIELD OFFICES, RE: INCLUSION OF ORGANIC FERTILIZERS IN THE LIST OF RECOMMENDED FERTILIZERS FOR ALL NATIONAL AGRICULTURAL PRODUCTIVITY PROGRAMS, USE OF ORGANIC FERTILIZER IN THE EXPANDED CORN PROGRAM, INTENSIFIED RICE PRODUCTION PROGRAM AND THE NATIONAL SOYBEAN PRODUCTION PROGRAM IS HEREBY APPROVED WITH THE FOLLOWING GUIDELINES:

1. THE USE OF ORGANIC FERTILIZER SHALL BE IN COMBINATION WITH CHEMICAL FERTILIZER IN ACCORDANCE WITH RECOMMENDED RATIOS AS DETERMINED BY THE SUB-COMMITTEE ON TECHNOLOGY;
2. THE ORGANIC FERTILIZER TO BE USED SHALL BE NFAC ACCREDITED PROCESSED ORGANIC FERTILIZER AND/OR LOCALLY PRODUCED ORGANIC FERTILIZER SUCH AS: AZOLLA, COMPOST AND FARM MANURE. THE NATIONAL FOOD AND AGRICULTURE COUNCIL'S COMPUTATION ON COST OF PRODUCTION SHALL BE ADOPTED.
