The EFSA therefore of employees in the active service as of March 1987 whose EFSA was partially/fully withdrawn as a result of their promotion on July 1, 1984 or thereafter is hereby restored effective on the date of the withdrawal.

Employees whether monthly/daily/contractual who were separated from the NIA service and subsequently reinstated/re-employed are no longer entitled to the EFSA.
