GSIS MEMORANDUM CIRCULAR NO. 2, 87:

: All Heads of Ministries; Chiefs of Bureaus and Offices; Managing Heads of Corporations, Owned and Controlled by the Government; Chief of Staff, NAFP; Provincial, City and Municipal Treasurers; Accounting and Disbursing Officers; and Others Concerned.

SUBJECT : IMPLEMENTATION OF THE INCREASE OF THE COVERED WAGE CEILING FOR MEDICARE CONTRIBUTIONS.

In January of last year (January 20, 1986), Executive Order No. 1079 was promulgated; the principal provisions thereof are the following:

- 1. The allowance of medicare dependents is increased to the same level of allowance of contributing members, effective immediately, and
- 2. The covered wage ceiling for medicare contributions is increased from P600.00 per month to P1,000.00 per month, effective January 1, 1987.

The Philippine Medical Care Commission, during its meeting on January 29, 1987, passed Resolution No. 87-1901, approving the immediate implementation of the increased contribution base as provided for in the above-mentioned Executive Order.
