1.0 Purpose

Pursuant to board Resolution No. 5507-88 Lated Nay 25, 1988 the grant of a Christmas boths equivalent to busic rate and allowances is hereby given in advance to coincide with the opening of the school year and to help exployees meet other economic needs and social obligations subject to the inles, procedures and guidelines of this Circular.

- 20 Coverage
 - 2.1 .IIA conthly and doily employees in the service as of May 15, 1983 are entitled to the advance Unistic Donus.
 - 2.2 Meirs of employees who passed away phior to the grant of this advance Christmas bonus shall be entitled to some in proportion to the service rendered during the period under review subject to item 5.0 hereof.
 - 2.3 contractual personnel directly hired by the STA (excluding consultants exployed pursuant to loan agreements) are entitled to the advance Christmas bonus based on their total contract remmeration authorized for the month of May 1933 excluding allowances for transportation, representation, board, loaging and/or per diens subject to item 3.1 hereof.
 - 2.4 MiA Auditing personnel who have been actually absigned to the MIA for at least four (4) months as of May 15, 1900 are entitled to the one-half (1/2) month Christmas bonus consisting of the following :

2.4.1 One-half (1/2) month basic pay pursuant to item 3.1 hereof,

2.4.2 One-half (1/2) month food subsidy authorized for the month of Hay 1988,

2.4.3 One-half (1/2) month COLA authorized for the month of May 1983;

- 2.4.4 One-half (1/2) south ENSA, if any, authorized for the south of May 1983.
- 5.0 Computation

the period under raview shall be reckoned from dovember 16, 1907 to day 15, 1908 covering a six month period or one-hundred eighty two (182) calendar days.

- 3.1 Basic Pay
 - 5.1.1 An outployee who has rendered at least four (4) months of service in the MLA as of May 15, 1903 shall receive one-half (1/2) month pay as advance dimistmas bonus based on the authorized mate as of May 15, 1903.
 - 3.1.2 An employee who has vendered less than four (4) months HIA service as of Hay 15, 1930 is entitled to the advance Unristmas bonus on a pro-rata basis applying the following formula :

No. of Calendar Days Served (Axcluding Vacation Leaves M/o. Pay) X Monthly Rate/ 182 Daily Mate X 30 days

A Clerk B with a basic pay of P 555.00/month on P 22.20/ day who entered the MIA service on March 1, 1983 or a total of 75 calendar days incurred an appregate total of three (3) days vacation leaves without pay during the period under review.

Monce, applying the formula, he is entitled to P 135.56 advance Christmas bonus.

3.2 Anelioration Allowance

The grant of one half (1/2) month AA (Advance Christmas bonus) for motably exployees shall be based on their authorized monthly basic salary as of Hay 1988.

For daily exployees, the allowance shall be equivalent to 10% of their authorized daily rate as of May 1983 multiplied by 30 calendar days.

3.3 COLA/medical allowance/Children's Allowance (if any)/Meal Subsidy/EFSA (if any)

A one-half wonth COLA, Medical Allowance, Children's Allowance (if any), Meal Subsidy and EFSA (if any) an employee is entitled to for the month of May 1988 is like wise authorized as part of the advance Christmas bonus.

4.0 Other Implementing Guidelines

Employees who do not meet the four (4) months residence requirements shall be given their bonus on a pro-rata basis applying the formula under section 3.1.1 hereof.

5.0 Disgualifications

The following are not entitled to the advance Christmas bonus :

- 5.1 An employee who served or is serving administrative/criminal penalty during the period from November 16, 1987 to May 15, 1988, except those penalties carrying fines/suspension of salary for less than one (1) week.
- 5.2 An employce separated from the NIA effective May 15, 1988 or earlier due to voluntary resignation/phase-out including those on terminal leave during the said period.

6.0 Funding

The bonus pay of those occupying positions authorized in the regular plantilla of personnel shall be charged against the current operating budget for 1988. Those whose positions are authorized under Project Floating Plantilla shall be charged against their respective project funds.

7.0 Responsibility of Implementing Officials

Chiefs of offices/projects shall be held responsible for any grant of the advance Christmas bonus which is not in accordance with this Circular without prejudice, however, to the refund of any excess payments by the employees concerned. Payrolls covering the mid-year pay of Central Office personnel shall be coursed thru the Assistant Administrator for Administrative Services.

8.0 Saving Clause

Cases not covered by this Circular shall be referred to the Administrator, Attention: Assistant Administrator for Administrative Services.

The grant of bonus herein provided for may be effected third week of May 1988, subject to availability of funds as certified by the Manager, Controllership Department.

Compliance herewith is enjoined.
