## SUBJECT : GRANT OF ADDITIONAL ALLOWABLE ALLOWANCES. TO CONTRACTULL PERSONNEL

Pursuant to Memorandum Order (MO) No. 177, s. 1988 and Corporate Budget Circular (CBC) No. 15, s. 1988 and as further approved and confirmed by the Department of Budget and Management in its letter dated 14 October 1988, grant of additional allowances to NLA contractual personnel as noted by the Board of Directors in its meeting on November 28, 1988, shall be effected subject to the following guidelines:

1.0 Coverage

All NLa contractual personnel in the service as of July 1987 or thereafter are covered by this circular.

2.0 Effectivity Date

The herein authorized additional allowances takes effect on July 1, 1987.

- 3.0 Allowances and Computations 3.1 Meal subsidy (MS) of P
  - 3.1 Meal subsidy (MS) of P 3.00 per regular working day (exclusive of Saturdays, Sundays and Legal Holidays) perofficial/employees shall likewise be authorized.

3.2 Parent employees whose childfen are not more than 21 years of age, unmarried and not gainfully employed are qualified for this allowance subject to the presentation of a birth certificate or any other acceptable secondary documents; the total number of qualified dependent-minor children shall not exceed four (4).

3.2.1 If both husband and wife are employed in the NIA, only one of them shall claim the allowance.

3.3 COL equivalent to 40% of basic pay but not exceeding \$750.00 per month.

It is understood that the adjusted COLm Of contractual personnel whose monthly basic salary is above P1,875.00 shall be pegged only at the allowable maximum level of P750.00 per month.

- 3.4 The Amelioration Allowance (AA) presently enjoyed by contractual personnel on a graduated scheme implemented under Memorandum Circular No. 70, s. 1980 shall henceforth be equivalent to 10% of the contractual personnel's basic monthly pay as mandated under letter of Implementation No. 97, s. 1979.
- 4.0 Payment Procedures and Funding
  - 4.1 Payment shall be subject to the availability of funds and to usual accounting and auditing rules and regulations.
  - 4.2 The herein authorized allowances for contractual employees shall be a proper charge against the project funds to which their remunerations are being charged and may only be given if funds are available for the purpose.

5.0 Responsibility/Liability of Chiefs of Office

Chiefs of Office concerned shall be responsible for the implementation of this circular in their respective areas of jurisdiction and shall be held liable for any deviation from the provisions, hereof, without prejudice, however, to the refund of any excess payments by employees concerned.

- 6.0 Incorporation into the 13th month pay for 1987 These additional allowance shall be incorporated into the 13th month pay for 1987 implemented under MC # 50, s. 1987.
- 7.0 <u>Saving Clause</u> Cases not covered by the provisions of this Circular shall be referred to the Administrator. Attention: Assistant Administrator for Administartive Services.
- 8.0 Provisions of existing memoorandum circulars inconsistent herewith are hereby repealed/modified accordingly.
