## MEMORANDUI CIRCULAR

: ALL MEADS OF DEPARTMENTS, BUREAUS AND AGENCIES OF NATIONAL AND LOCAL GOVERNMENTS, INCLUDING GOVERNMENT OWNED AND CONTROLLED CORPORATIONS

SUBJECT : Decisions on Disciplinary Cases Involving Dishonesty, Graft and Corruption and Malversation of Public Funds

Pursuant to Sec. 27, Article II of the 1987 Constitution, the State has adopted the policy that it shall maintain honesty and integrity in the public service and shall take positive and effective measures against graft and corruption.

The Civil Service Commission, as the central personnel agency is mandated among others to adopt measures to promote integrity in the Civil Service and to prescribe, amend and enforce suitable rules and regulations pursuant to Sec 9 (b) of Presidential Decree 807. In view of the Constitutional guarantee that all persons shall have the right to a speedy disposition of their cases before all judicial, quasi-judicial, or administrative bodies, the Commission has adopted the attached Resolution No. 89-391, dated June 15, 1989 which provides as follows:

- 1. All cases that pertain to dishonesty, graft and corruption and malversation of public funds shall be investigated, heard and decided by the disciplining authority in the agency within ten (10) days from the date of filing of the administrative case;
- 2. The Commission shall render a decision on cases appealed to it or in cases over which it has exercised original jurisdiction within ten (10) days from the date of receipt or in accordance with the preceding paragraph, respectively; and
- 3. Continuos hearing shall be conducted until a case is finally decided and acceptance of the evidence and witnesses presented shall be signed at the end of each hearing by both parties and attested by the hearing officer.

Strict compliance with the above guidelines is hereby enjoined.
