SUBJECT : Amending the provisions of Sub-paragraph 5.3 of the
National Budget Circular No. 391, implementing guide-
lines for Executive Order No. 151, dated March 19, 1987.

1.0 Purpose

This Circular is issued to effect necessary amendments to
certain provisions of National Budget Circular No. 391,
implementing guidelines for Executive Order No. 151, dated
March 19, 1987.

2.0 The provisions of Sub-paragraph 5.3 of National Budget
Circular No. 391 is hereby amended to read as follows:

"5.3 Officials and employees whose official permanent station is within Metropolitan Manila Area or in places other than Metropolitan Manila Area and are authorized to travel in places within fifty (50) kilometer radius of the city/municipality wherein their official station is located shall be allowed only per diem and allowances herein authorized upon presentation of proofs, duly supported by receipts of expenses incurred, that they stayed in the place of their assignment during the whole duration of their official travel and are not commuting daily from the place of their assignment to the place of their residence or official station otherwise, they shall be allowed only reimbursement of actual fare at the prevailing rates of transportation of the authorized transportation from permanent official station to the destination or place of work and back and a reasonable cost of actual meal allowance corresponding to the units stipulated under Sub-paragraph 5.3 of Joint DEM-COA General Circular No. 86-1."

3.0 The effectivity of this Circular shall be July 1, 1989.
