MEMORANDUM CIRCULAR

SUBJECT: <u>Grant of Fifteen Per Cent (15%) Adjustment in</u> Salaries/Wages in Advance of Salary Standardization.

A fifteen per cent (15%) adjustment in salaries/wages of NIA employees has been approved under Board Resolution. No. 5829-89 dated December 18, 1989 as partial implementation of R. A. No. 6758 prescribing a revised compensation and position classification system in the government, including government-ouned and/or controlled corporations. This measure is being adopted due to the expected delay in the implementation of the salary standardization by government corporations.

Fursuant thereto, you are hereby directed to adjust the actual basic salaries/wages of employees as of June 30, 1989 by fifteen per bent (15%) in accordance with the hereunder rules and regulations.

1.0 Coverage

All , NIA personnel whether permanent, temporary, contractual, casual or emergency in the active service as of June 30, 1989 are covered by this Circular.

2.0 Effectivity

The herein authorized 15% salary/wage adjustment shall be effective July 1, 1989.

3.0 Definition

3.1 The actual basic salary/wage of an employee for purposes of this Circular shall mean the basic salary/wage actually received as of June 30, 1989 exclusive of cost of living, amelioration, meal, children's, medical, emergency allowances and/or any other additional benefits. 3.2 The herein authorized 15% salary/wage adjustment shall be deemed part of the salary/wage adjustment that shall be received by an employee as a result of the full implementation of the salary standardization. If the total salary/wage adjustment that shall be received by an employee upon implementation of same is less than the amount that he/she is entitled to under this Circular, he/she shall refund the difference within a period of three (3) months upon receipt of a Notice of Salary Readjustment/Refund.

4.0 Effect on Amelioration/Cost of Living Allowances

- 4.1 The Amelioration Allowance being enjoyed by employees shall be adjusted accordingly as a result of the herein salary adjustment.
- 4.2 The COLA provided under MC No. 056, s. 1987 shall be adjusted accordingly when an employee's salary as adjusted under this Circular exceeds P1,375.00 per month applying the formula "40% of basic salary but not to exceed P750.00". This adjustment in COLA, however, is exclusive of the additional P100.00 monthly COLA granted to NIA employees pursuant to MC No. 049, s. 1988.

5.0 Disqualifications

- 5.1 An employee under suspension from Office covering any period between July 1, 1989 and thereafter, for the duration of his suspension.
- 5.2 An employee on vacation/sick leave without pay covering any period between July 1, 1989 and thereafter, for the duration of the leave without pay.
- 5.3 An employee separated from the NIA as of June 30, 1989 including those on terminal leave on such a date.

6.0 Notices of Salary/Wage Adjustment (NSA/NWA)

Officials authorized under MC No. 12, s.1984 to sign/approve Notices of Salary/Wage Adjustments are hereby directed to notify each employee entitled to a salary/wage adjustment under this Circular through a Notice of Salary/Wage Adjustment in a prescribed form, attached as Annexes "A" and "B", hereof, subject to review by proper authorities.

7.0 Payment Procedures and Funding

7.1 Payment shall be subject to the availability of funds and to the usual accounting and auditing rules and regulations. 7.2 The fifteen per cent (15%) salary/wage adjustment of those occupying positions authorized in the Regular Plantilla of Personnel shall be charged against the Current Operating Budget for 1989. The adjustment for project employees as well as contractual personnel shall be charged against their respective project funds and may only be given if funds are available for the purpose.

8.0 Responsibility of the Chiefs of Offices and Recipient Employee/Official

The Chiefs of NIA Office concerned shall be held personally liable for any payment not in accordance with provisions of this Circular without prejudice, however, to the refund of any excess payments by the employee/official concerned.

9.0 Saving Clause

Cases not covered by the provisions of this Circular shall be referred to the Administrator, Attention: Officer-in-Charge, Office of the Assistant Administrator for Administrative Services.
