MEMORANDUL CERCULAR

The Leputy Administrator, the Assistant Administrators, Department Managers, Regional Irrigation Managers, Operation Managers, Project Managers and All Others Concerned.

SUBJECT : Amendment to NO # 29, S. 1990

In the original scheme of MC $_{H}$ 29, S. 1990, all Sub-Allotment Advices released to regional/project offices are to be provided with full cash support. Said scheme has become impossible to implement due to the fact that Letters of Advice of Allotment or obligational authority which NIA receives from the Department of Public Works and Highways are only partially supported with eash. Cash is treated as a "common fund", i.e. it can be re-allocated to any project/activity as long as it does not exceed the obligational authority for the said project/activity. It is only logical therefore, that NIA should adopt the same method.

In order for the Central Office to closely monitor the difference between the obligational authority (SAA) and cash made available to the regional/project offices, all accounting units of regional/project offices which directly receive SAAs and funding checks from the Central Office are to submit monthly to the Controllership Pepartment a Comparative Statement of SAA and Cash Dalance (Annex A).

This memorandum circular takes effect immediately and supersedes all issuances or parts of issuances contrary to the above.
