: Employment Status of Personnel under Foreign Assisted Projects

It has come to the attention of the Civil Service Commission that personnel of foreign-assisted projects are given permanent appointments which by their nature are considered co-terminous.

Section 9(4), Book V of Executive Order No. 292, otherwise known as the Administrative Sode of 1987, enumerates the positions which are considered under the non-career service. These include "contractual personnel or those whose employment in the government is in accordance with a special contract to undertake a specific work or job, requiring special or technical skills not available in the employing agency to be accomplished within a specific period, which in no case shall exceed one (1) year and performs ... or accomplishes the specific work or job under his own responsibility with a minimum of direction and supervision from the hiring agency".

The above-quoted provision is clear that the employment status of personnel hired under foreign-assisted projects is considered coterminus that is they are considered employees for the duration of the project: or until the completion or cessation of said project.

In view of the foregoing, it is hereby directed that appointments of personnel of foreign-assisted projects be issued and approved as co-terminous with the project.
