SUBJECT : SEPARATE BILLING OF THE CURRENT ISF AND BACK ACCOUNTS

The present practice of combining the billing of current and back ISF accounts into one Bill and Statement of account makes the total amount due, in many instances, appear to be beyond the farmer's capacity to pay. Under such situation, the irrigation user tend to just ignore paying the dues, including the current charges. This then would contribute to the piling-up of unpaid back accounts. However, if the billing of the current ISF charges is segregated from that of the back accounts there is a greater chance that NIA could at least be paid for the current charges.

As a measure of encouraging farmers to pay their ISF accounts and with the objective of improving NIA's collection performance, it is directed that billing of the current ISF charges be made separately from that of the back accounts. For this purpose, attached for easy and ready reference are proformat of the BILL for the current ISF charges marked as Annex "A". The Bill shall be served regularly every cropping season to farmers on or before threshing time and the STATEMENT OF BACK ISF ACCOUNT marked as Annex "B" of this circular shall be rendered to farmers once a year until fully paid. The NIA Field Offices concerned shall reproduce these Forms for their use. Bills (Form A) should be numbered in numerical series indicating the calendar year of both dry/wet season that are being billed. The series is only good for one calendar year and start a new series every year.
