Pursuant to the instruction of President to hasten  
the implementation of the Farm-to-Market Roads Program,  
you are hereby directed to:

- a) Allow capable local government units (LGUs) to  
undertake the construction of their respective  
farm-to-market roads projects on a reimbursement  
basis;

- b) Where LGUs are not capable to undertake the projects due to lack of facilities/equipment, the Regional Field Units (RFUs) of the DA and/or the DPWH Regional/Offices will handle the construction either on contract and/or reimbursement basis;
- c) All LGUs should be advised through the DA-RFUs of the commencement of the projects in their localities.
