MEMORANDUM CIRCULAR

SUBJECT : Creation of Caraga Administrative Region (Region 13) Per Republic Act No. 7901

For the information and guidance of all concerned, the provinces of Agusan del Norte, Agusan del Sur, Surigao del Norte, Surigao del Sur and the cities of Butuan and Surigao have been constituted to form Region 13 to be known as Caraga Administrative Region per Republic Act No. 7901.

As likewise embodied in Sec. 3 of RA 7901, the province of Sultan Kudarat under Region 12 shall now be part of Region 11.

The creation of Region 13 affects NIA Regions 10, 11 and 12. The provinces composing the affected Regions are presented below:



For the smooth and orderly turn-over/take-over of the supervision of NIA offices within these regions, the Regional Manager of Region 10 has been designated as the OIC of Region 13 on a concurrent capacity. The present staff of Region 10 shall also be responsible for the planning, implementation and coordination of all irrigation activities within the Caraga Region.

The chiefs of PIOs as well as the chiefs of NISSs within the affected provinces have been instructed to report to the OIC of Region 13 for briefing regarding plans, programs, etc. of their respective offices. The regional offices concerned were also advised to effect the transfer of all pertinent records including books of accounts balances of offices affected by the reorganization of the above mentioned provinces.

Henceforth, all transactions and communications pertaining to said provinces shall now be addressed to their new regional assignment.

In view of the creation of the Caraga Administrative Region (Region 13) as embodied in Sections 1 to 4 of RA #7901, comprising the provinces of Surigao del Norte, Surigao del Sur, Agusan del Norte, Agusan del Sur and cities of Surigao and Butuan, you are directed to transfer the provinces under Region 10 as specified in said RA to Region 13.

In line with the thrust of the agency to establish a lean but strong organization, you are hereby designated as Officer in Charge of Region 13 on a concurrent capacity. Your present staff shall also be responsible for the planning, implementation and coordination of all irrigation development/operation activities under the Caraga Region.

This designation does not entail additional compensation but you are entitled to an honorarium pursuant to MC #1 s. of 1996.

A separate directive is likewise issued to the Regional Manager of Region 11 with regards to the transfer of jurisdiction of Surigao del Sur from Region 11 to Region 13.

You are therefore directed to submit a joint report to the undersigned on the actual date of transfer/takeover of these offices.
