

The primary objective of the PSMT is to provide the top level management with a comprehensive, reliable, unbiased and accurate information, observations, evaluations and recommendations concerning the implementation of the projects and O & M of irrigation systems.

To attain its objectives, the PSMT shall monitor and evaluate the plans, programs, activities and performance of the various operating units at the central and field offices including the working committees that are involved in the procurement of goods and services, and in the implementation of contracts and force account works.
