TO : THE DEPUTY ADMINISTRATOR, ASSISTANT ADMINISTRATORS, DEPARTMENT,REGIONAL /OPERATIONS /PROJECT MANAGERS, IRRIGATION SUPERINTENDENTS,PROVINCIAL IRRIGATION MANAGERS and all others concerned

SUBJECT : <u>APPLICATION AND PROCESSING OF RETIREMENT CLAIMS</u> UNDER R.A. 1616

Quoted hereunder in full is GSIS Memorandum Circular No. 3-97 on the above-captioned subject for the information and guidance of all concerned viz:

MEMORANDUM CIRCULAR No. 3-97

TO : All Heads of Departments and Agencies, Chiefs of Bureaus and Offices, Heads of Government-Owned and controlled Corporations, State Universities and Colleges, Governors, Mayors and others concerned

SUBJECT : Processing and Adjudication of Retirement Claims under section 12 (c) of R.A. 1616 as amended by R.A. 4968

Under the provisions of R.A. 8291, also known as the GSIS Act of 1997 which took effect June 24, 1997, the processing and adjudication of retirement applications under Sec. 12 (c) of R.A. 1616 as amended by R.A.4968, shall be discontinued by the GSIS.

The Agencies concerned shall process and pay the gratuities of their employees under R.A. 1616 subject to GSIS clearance.

,

To implement this particular provision of R.A. 8291 the GSIS shall assist the agencies concerned to gain the expertise in the processing and adjudication of retirement claims under R.A. 1616.

Any employee, appointive or elective, regardless of age and employment status is eligible to retire under Sec. 12 (c) of R.A. 1616 as amended by R.A. 4968 subject to the following conditions:

- 1. Must have rendered service prior to June 1, 1977 effectivity of P.D. 1146;
- 2. At least 20 years service in the aggregate;
- 3 Last 3 years of service must be continuous, meaning, no separation or leave of absence without pay of more than one (1) year within the last three (3) years of service;
- Gratuity to be computed based on the highest salary received.

Stated below is the formula and sample for computing gratuity benefigs:

Gratuity months = Factor x Total service

 $= 1.0 \times 20 \text{ yrs.}$

+ 1.5Mo.x (21-30) yrs.

+ 2.0 Mo. x in excess of 30 yrs.

Example 1: Total Service (TS) = 35 yrs.

Highest salary = P18,749.00

Gratuity mos. $1.0 \times 20 = 20$

 $1.5 \times 10 = 15$

 $2.0 \times 5 = 10$

service 35yrs.= 45 gratuity mos.

Amount of Gratuity= Gratuity mos. × Highest salary received

= 45 × P 18,749.00

= P843,705.00

Example 2 : T.S. = 29 years

Highest salary received = P10,863.00

Gratuity months = $1.0 \text{ Mo.} \times 20 = 20$

1.5 Mo. x 9 yrs. = 13.5 29 yrs. 33.5 gratuity service months

Amount of Gratuity = 33.5 x ₱ 10,863.00

= P363,910.50

The refund of retirement premuims paid, personal share with interest and government share without interest shall be payable by the GSIS. A copy of the approval together with the service record shall be forwarded to the GSIS inorder to effect the refund the soonest possible time.

Please be guided accordingly.

SARINO President & General Manager " In view of this issuance, retirement applications of field office personnel under R.A. 1616 shall be forwarded to the Manager, Personnel & Records Management Department, Central Office, for processing prior to approval by the Administrator. The delegated authority granted to Regional/Project/Operations Managers to endorse retirement applications under R.A. 1616 directly to GSIS is hereby revoked. Authority for said officials to directly endorse other retirement modes such as P.D. 1146, R.A. 660 to GSIS still remains in effect.

To ensure prompt payment of gratuity benefits, all Heads of Offices are directed to submit to Central Offics, (Attn. Manager, Budget Division, Controllership Department) a list of retirees under R.A. 1616 including estimates of the gratuity and terminal leave benefits on the first week of January of each calendar year for inclusion in the Budgets.

Previous issuances inconsistent herewith are hereby revoked accordingly.
