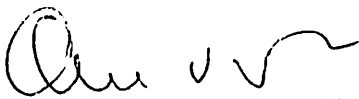
TO : ALL REGIONAL IRRIGATION MANAGERS, OPERATIONS MANAGERS AND ALL OTHER CONCERNED

SUBJECT : INCLUSION OF THE IA REGIONAL FEDERATION PRESIDENTS IN THE PBAC OF REGIONAL OFFICES AND INTEGRATED SYSTEMS IN THE NIA

As part of the Agency's thrust to enhance transparency in the bidding process and in support of this office policy to empower our partners, the farmers, in attaining food security in the next millenium, the Presidents of the Regional Federation of Irrigators' Associations (IA) is hereby included as additional member of the Pre-qualifications, Bids and Awards Committee (PBAC) in the regional offices and integrated systems of the NIA. MEMORANDUM CIRCULAR

TO: ALL REGIONAL IRRIGATION MANAGERS, OPERATIONS
MANAGERS, PROJECT MANAGERS AND ALL OTHERS CONCERNED

SUBJECT: RECONSTITUTION OF THE PREQUALIFICATIONS, BIDS
AND AWARDS COMMITTEE (PBAC) IN THE REGIONAL,
INTEGRATED SYSTEMS AND PROJECT OFFICES

In compliance with the spirit of DPWH Department Order
No. 23, Series of 1991 dated January 28, 1991 effecting the
reconstitution of the Prequalifications, Bids and Awards
Committee and pursuant to the Implementing Rules and
Regulations of P.D. 1594, as amended, the general composition
of the PBAC in the RIOs, UPRIIS, MARIIS and Foreign-Assisted
Project Offices, subject to the approval of the Administrator,
shall be as follows:

A. Chairman - at least a third ranking
official but preferably a
Division Manager of the
Office.

B. Member - Secretary - a legal or an administrative
officer of the Office.

C. Regular Member - - - at least a Section Chief,
from various Divisions of
the Office.

D. Provisional Member - - - an official of the Office
with experience in the type
of project to be bidden and
in project management design-
ated on a project-to-project
basis.

E. Member from the
Private Sector

--- one qualified representative
from any of the following
organizations who shall be
a non-voting member:

a) End-user group or non-
governmental organization.

b) Philippine Institute of
Certified Public
Accountant.

c) Philippine Institute of
Civil Engineers or Phil-
ippine Constructors Asso-
ciation or National
Confederation of Contrac-
tors Associations of the
Philippines, Inc.

No PBAC member shall serve for a period exceeding one (1)
year, without prejudice to his redesignation to the PBAC after
the lapse of one (1) year from the expiration of his term, unless
sooner replaced or terminated.

Accordingly, appointment of the PBAC Technical Secretariat
members shall be approved by their respective Regional, Opera-
tions or Project Managers and shall serve also for a term
similar to the conditions of the PBAC members.

To ensure continuity of works, however, every time a PBAC and
Technical Secretariat are reconstituted, one (1) incumbent
member shall be retained.

This MC takes effect immediately and shall be in force
until further notice.
