SUBJECT : Availment of Centennial Leave in the NIA

In this connection, NIA personnel may avail of Centennial Leave subject to the following guidelines, viz:

- 1. Centennial Leave is not deductible on one's leave credits and noncommutable;
- 2. Said leave may be availed of on a staggered basis and can also be enjoyed by visiting other historical place of the employee's choice;
- 3. Fersonnel availing of this Centennial Leave must submit to their respective Personnel Division/Unit their corresponding tickets and/or Certificate of Appearance as proofs of their visit to a historical site/s;
- 4. Chief of Offices/Supervisors concerned must see to it that delivery of services is not impaired any time as a result of this activity;
- 5. Personnel interested in visiting the Expo Filipino at Clark Air Base should coordinate thru their Chiefs of offices with the Equipment Management

Department (EMD) of the Central offices for scheduled trips to Clark Air Base, Angeles City.

In view of the tight financial situation being experienced by the Agency, this office is not in a position to extend any financial support to this endeavor. Hence, except for the service vehicles which may be used in going to and from Angeles City, employees concerned shall shoulder all other expenses relative to these trip such as entrance fees and food.

This Memorandum Circular takes effect immediately.

TO : ALL HEADS OF DEPARTMENTS, BUREAUS AND AGENCIES OF THE NATIONAL AND LOCAL GOVERNMENTS, INCLUDING GOVERNMENT-OWNED AND CONTROLLED CORPORATIONS, AND STATE COLLEGES AND UNIVERSITIES

SUBJECT : Authority to Visit Centennial Exposition 1998 at Clark Air Base

The 1998 Centennial Celebration is a significant milestone in the history of the Philippines. It is an opportune time to heighten the sense of national pride of Filipinos and inspire them to be more productive members of the society.

In line with CSC Resolution No. <u>98–1051</u>, all government officials and employees are hereby enjoined to participate in the Centennial activities, one of which is a visit to the Centennial Exposition at Clark Air Base on official time. The Centennial Exposition is intended to be the showcase of Filipino trade, culture, arts, environment, and international relations and is considered as alternative economic center in Luzon.

At the discretion of the agency management and subject to the availability of funds, government employees may be granted the privilege of visiting the Expo on official time.

The internal mechanisms for the availment of this benefits will be formulated by respective agencies within these general guidelines:

1. Employees may be granted the privilege of visiting the Centennial Exposition on official time for a maximum of three days anytime during the period 6 June 1998 to 15 June 1999.

- 2. At the discretion of the head of office, expenses for visits to the Expo may be fully or partially subsidized by an office or agency subject to usual accounting and auditing rules.
- 3. Head of offices must schedule the visits of their employees so that delivery of public services is not impaired at any time.
- 4. Said benefit is non commutable and may be availed of only during the specified period.
- 5. Costs of ticket and other details relative to the visit can be obtained from the Department of Tourism, Paskuhan Village Complex, San Fernando, Pampanga, Telephone numbers (045) 961-2665; Faxtel (045) 961-2612.

All concerned are hereby enjoined to cooperate towards the success of Expo Pilipino.

In the exercise of their discretion, heads of offices/agencies may fully or partially subsidize such visits subject to the usual accounting and auditing rules.
