WHEREAS, the Local Scholarship Program has been established to enhance professionalism in the civil service;

WHEREAS, there are implementing guidelines and operating procedures in the admission requirements to the LSP;

WHEREAS, there is a need to explicitly state the pertinent qualification requirement;

WHEREFORE, the Commission **RESOLVES** to amend the pertinent provision on the matter, to read as follows:

"QUALIFICATION REQUIREMENT

An employee who has previously earned masteral units or who has completed academic requirements and/or is on thesis writing may avail of the LSP grant to complete his/her original course or pursue another course."
