MEMORANDUM CIRCULAR

T O : THE DEPUTY ADMINISTRATOR; ASSISTANT ADMINISTRATORS; HEADS OF DEPARTMENTS AND STAFFS; REGIONAL IRRIGATION MANAGERS; OPERATION MANAGERS; HEADS OF FOREIGN ASSISTED PROJECTS; PROVINCIAL IRRIGATION OFFICERS; IRRIGATION SUPERINTENDENTS; AND ALL OTHERS CONCERNED National Irrigation Administration

SUBJECT : <u>REVISED GUIDELINES ON THE GRANT OF LOYALTY</u> AWARD FOR CY 2002

NIA Board Resolution No. 7101-02, s. 2002 dated May 27, 2002 approved the grant of Loyalty Award for CY 2002 consisting of a Cash Gift of Five Hundred Pesos (P500.00) per year of service contingent on the availability of Agency savings.

The Loyalty Award shall be granted to NIA personnel regardless of employment status provided they meet the residence requirement during the period under review, i.e., from June 23, 2001 to June 22, 2002.

- b. Those who shall have completed their first ten (10) years of continuous service in NIA on June 22, 2002, its Anniversary date, shall receive a cash award of P5,000.00 and a Certificate of Recognition.
- c. Those who, on June 22, 2002, shall have completed another five (5) years of continuous service since their last loyalty grant shall receive a cash award of P2,500.00.

Pursuant to Civil Service Commission Memorandum Circular No. 06, s. 2002, the revised policies on the grant of Loyalty Award are as follows:

1. The particular agency where the employee or official completed the ten (10) years of continuous and satisfactory service shall grant the award.

2. An official or employee who incurred an aggregate of not more than 50 days authorized vacation leave without pay within the 10-year period shall be considered as having rendered continuous service for purposes of granting the loyalty award.

In the same way, an official or employee who incurred an aggregate of not more than twenty-five (25) days authorized vacation leave without pay within the 5-year period may qualify for the 5-year milestone loyalty award.

3. Effective January 1, 2002, continuous and satisfactory services in government for purposes of granting loyalty award shall include services in one or more government agencies without any gap.

Services rendered in other government agencies prior to January 1, 2002 shall not be considered for purposes of granting the loyalty award.

Chiefs of Offices concerned shall be held personally liable for any payment not in accordance with the provisions of this Circular without prejudice, however, to the refund of any excess payments by the employees concerned.

Inquiries relative to the granting of this Award shall be directed to the Assistant Administrator for Administrative Services attn., Department Manager, Personnel & Records Management Department.

All circulars or provisions therein which are inconsistent with the provisions of this Circular are hereby amended/modified accordingly.
