### LRA Circular No. 03-2003

TO : ALL REGISTERS OF DEEDS and BRANCH REGISTERS OF DEEDS

SUBJECT : ADDITIONAL REQUIREMENT: RE: REGISTRATION OF TRANSACTIONS INVOLVING THE SALE OR TRANSFER OF OWNERSHIP OF AGRICULTURAL LANDS

As a gesture of cooperation with the National Irrigation Administration (NIA), in its relentless efforts to effectively implement its nationwide program of intensifying irrigation fee collection, this Authority deems it necessary to provide further assistance by

supplementing the provisions of NALTDRA (LRC) Circular No. 93 dated December 2, 1986, so as to include the following, to wit:

"In all transactions involving sale or any other mode of transfer of ownership of agricultural lands, the registrant shall now be required to submit, as an additional requirement, a certification from the National Irrigation Administration (NIA) that irrigation fees due thereon had already been duly paid. Failure of the registrant to submit the certification shall cause to defer the transfer of ownership until such time that said Certification shall have been submitted."

All other provisions of the aforementioned circular not inconsistent herewith shall remain effective and all Registrars of Deeds are hereby directed to strictly implemented the same.

This Circular shall take effect immediately upon its approval.

Strict compliance is hereby enjoined.

You are all enjoined to fully take advantage of this opportunity to enhance our ISF back accounts collection and extend full cooperation with the respective Regional Offices of LRA/Register of Deeds in the dissemination of aforecited LRA Circular.

The Provincial irrigation Engineers are likewise urged to avail of this circular in attending to back account collection related to pump equity and amortization from construction, repair and rehabilitation of Communal Irrigation Systems (CIS).

Be guided accordingly.
