SUBJECTSUPPORT OF DA IN THE IMPLEMENTATION OF RA 8172 "AN
ACT PROMOTING SALT IODIZATION NATIONWIDE AND FOR
OTHER RELATED PURPOSES"

RA 8172 or the ASIN Law, which was enacted in December 1995, mandates the iodization of all salt for human and animal consumption. Salt iodization is among the most cost-effective interventions to prevent iodine deficiency disorders (IDD), which is the leading cause of preventable mental retardation and poor psychomotor development among young children resulting to poor work performance and low productivity in adulthood.

After seven years, compliance to RA 8172 remains very low with only about 25 percent of all households using iodized salt. It is for this reason that I, as chair of the NNC Governing Board and Salt Iodization Advisory Board, urge you to help in the campaign for universal salt iodization and ensure the full-swing implementation of the law.

Specifically, you are directed to:

- 1. ensure that your canteen concessionaires or operators use only iodized salt. The NNC Secretariat will be giving you the appropriate test kits to use in determining the presence of iodine in the salt; and
- 2. conduct an information campaign about the law directed to your employees and their families, along with the agency-clientele to encourage the use of only iodized salt.
