SUBJECT: **AMENDMENT OF SECTION V.2.a OF THE IMPLEMENTING
GUIDELINES (IG) FOR THE COMPROMISE AGREEMENT
PROGRAM (CAP) IN SETTLING IRRIGATION SERVICE FEE
(ISF) BACK ACCOUNT OF FARMER BENEFICIARIES OF
NATIONAL IRRIGATION SYSTEM**

The NIA Board of Directors in its meeting on July 12, 2004 approved the Amendment of Section V.2.a of the Implementing Guidelines (IG) for the Compromise Agreement Program (CAP) in Settling Irrigation Service Fee (ISF) Back Account of Farmer Beneficiaries of National Irrigation System through Resolution No. 7261-04 series of 2004 as follows:

“NIA shall give due course only to Letter of Intent with Confirmed Statement of Accounts of CAP availment received by NIA on or before December 31, 2004.”

The new deadline is perceived to improve CAP performance which will result to substantial collections in ISF Back Account and Current Account.

Compliance is enjoined.

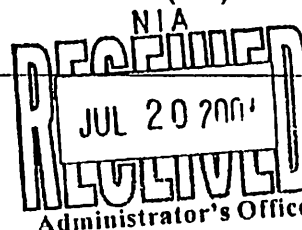
