**SUBJECT : EXTENSION OF AVAILMENT OF COMPROMISE AGREEMENT IN  
SETTLING IRRIGATION SERVICE FEE (ISF) BACK ACCOUNT OF  
FARMER IRRIGATION BENEFICIARIES OF NATIONAL  
IRRIGATION SYSTEM (NIS)**

The Compromise Agreement Program (CAP) targeted to clear 573,208 Irrigation Service Fee Register's (IFR's) with Back Accounts (BA).

As of December 31, 2004, the deadline for availment, 435,755 or 76% Statement of Accounts (SOA) were prepared and distributed to the beneficiaries of which 177,501 or 31% have submitted their letters of intent and only 119,015 SOAs were confirmed which gives a low percentage of accomplishment of only around 21%.

Those who have not yet availed the program have manifested their interest to avail the benefits of CAP. In order to give chance to the concerned farmer irrigation-beneficiaries, the NIA Executive Committee (Execom) in its meeting on January 3, 2005 approved the Extension of CAP availment until June 30, 2005. The basis of the Execom's approval was the agreement reached during the NIA Managers Conference held last December 16, 2004.

The NIA Board of Directors in its Special Board Meeting on February 21, 2005 approved through Resolution No. 7307-05 Series of 2005 the request for Extension of Availment of Compromise Agreement in Settling Irrigation Service Fee (ISF) Back Account of Farmer Irrigation-Beneficiaries of National Irrigation System (NIS) until June 30, 2005. Attached is a copy of the NIA Board Resolution for reference.


