SUBJECT : IMPLEMENTATION OF ISF RATES FOR ANNUAL CROPS AND FISHPONDS.

Pursuant to NIA Board Resolution No. 7364-06, series of 2006, the following rates of Irrigation Service Fees (ISF) for annual crops and fishpond are hereby imposed, to wit:

<u>Rates</u>

1) Annual Crops

a) Banana, etc.

Cash equivalent of 7-1/2 cav/ha/annum

2) Fishpond

a) Diversion Dam Cash equivalent of 5 cav/ha/season

b) Reservoir Dam

Cash equivalent of 6 cav/ha/season

c) Pump System

Cash equivalent of 15 cav/ha/season

Irrigation water for rice production shall have a higher priority over annual crops and fishpond purposes, such that there shall be no land area for fishpond purposes exceeding 10% of the service area of each system/district.
