SUBJECT : RECONSTITUTION OF NIA COMMITTEE ON DISCIPLINE (COD)

Secretariat : Administrative & Finance Division

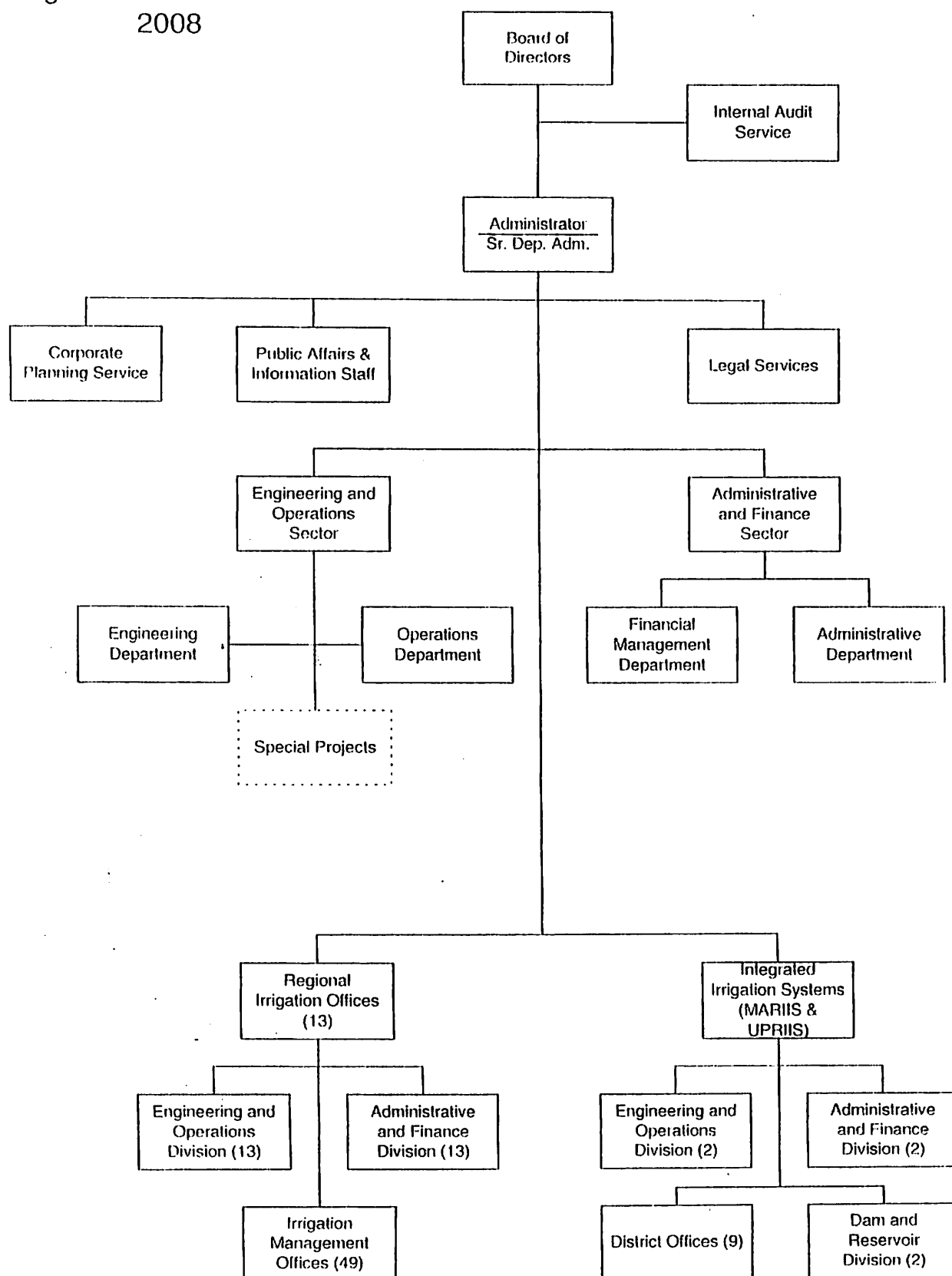
