SUBJECT AMENDMENT TO MC NO. 25, SERIES 2009 RE: SUPPLEMENTAL GUIDELINES TO MC NO. 20, SERIES 2007 SPECIAL POLICY FOR VIG ON SERVICE FEE FOR DRD OPERATIONS OF UPRIIS

As a result of the special deliberation and workshop between the Acting Operations Manager and among the Division Managers of UPRIIS on March 7, 2012 in Busuanga, Palawan, the group unanimously agreed on the following:

- 1) That the DRD will shoulder one hundred percent of the personal expense (PS) of the UPRIIS Head Office;
- That the maintenance and other operating expense (MOOE) of the UPRIIS Head Office will be *proportionately* shared by the five Irrigation Management Office or Division 1 to V based on the 104,095.62 hectares irrigated area;
- 3) That the ten percent (10%) share of DRD to the NIA Central Office expenses will be reduced to five percent (5%) similar to the 5% project management fee.

Through this sharing scheme, the VIG of UPRIIS will be equitably distributed among its responsibility centers.

The proposed amendment in the computation of VIG for UPRIIS DRD shall be used in the viability performance evaluation of the integrated system starting calendar year 2011.
